LCAM 2019

Let's talk about the 72nd Leadership Conference & Annual Meeting (LCAM) in Milwaukee, WI on September 18 – 21, 2019. Five of our chapter representatives attended which were myself (Pam) along with Kristina Helm, incoming Vice President, Jessica Emrick Davies, Advisor, Davna Gould and Gina Hess. Our EWI Corporate Board along with the LCAM committee pulled together a great venue with Academy of Leadership (AOL) sessions, a local reading rally, keynote speakers, professional development breakout sessions, a beach party and end with our annual meeting. So much wrapped up in four days! If you have the chance to attend LCAM you should take advantage of it. The professional development alone is worth the money to send you.

The Reading Rally took place on Wednesday morning with us reading to the Next Door Foundation children. If you haven't had a chance to sit with a child in his or her classroom and watch their eyes light up as your read a book to them, then you are definitely missing out. It's one of the highlights of LCAM. The kiddos were each given the featured book Ivy Grace and the Birthday Monster. The Reading Rally organizers had the author, Jamie Vacho Knisbeck, read the book to the children and the Illustrator, Charlie Christman, had fun asking the kids to tell him parts of animals and he made a monster cartoon based on what they told him. EWI chapters made a huge impact on this school by donating 2250 new books, 956 sling backpacks, and over \$3,600 worth of volunteer hours to the school for Reading Rally 2019!

Wednesday afternoon, Kristina and I attended the Leadership Caucus where our Corporate President, Felicia J. Senter, presented her theme of Empower, Engage, Inspire. Her action plan is membership, cohesive teams, road map to leadership, networking, and mentors. Cortney Ihde, Corporate EWI executive assistant, talked to us about Growth Zone and asked that every chapter member log in and update their profile. Also, they are introducing Higher Logic, which is like the old My EWI page. It should be ready to launch around November 1 for the first phase. The second phase will have mentor matching discussion pages and a mobile app for your cell phone.

Thursday morning was our keynote speaker, Karen McCullough, talking about how change is good, and then on Friday morning, she spoke on how to lead and succeed in a multigenerational world. She was so energetic and downright funny. The whole room had their heads nodding in agreement on some of the points she brought up. Some of the things I wrote down were our hidden self is the learning self, our blind self needs to change, and our unknown self evolves daily. We must be open to change and all the good that it brings about. She also relayed that gratitude and emotional support needs to become a daily ritual. Thursday after the keynote speaker, we broke out into the AOL sessions. Lori Giovannoni, affectionately known as Lori G, put on another attention-grabbing Lessons in Leadership. She said to lead means to guide into the unknown. Outstanding leaders come from quality. One equal human being is equal to all her representatives regardless of title. Your success is my reward!

She conducted an exercise in introverts and extroverts. Myths about introverts are that they are shy, don't like to talk, rude or aloof, prefer being alone and that they don't want to be an extrovert. Actually, Introverts are motivated to succeed. Instead of recognition, an introverted leader gains more satisfaction from maintaining the team's productivity and high-quality work. They value relationships because they are motivated by quality and productivity, they can seem disconnected from other people or a bit hesitant to build relationships. However, the relationships the introvert builds are driven by a different set of priorities.

Myths about extroverts are they are great orators, natural leaders, they lack introspection, are self-absorbed and don't value other's opinions as much as their own. Extroverts are comfortable with people and can take the mantel of leadership with ease. They are quick decision makers. Most extroverts find it relatively easy to make such decisions with little delay. Extroverts have the cultural advantage of being viewed as an effective leader by virtue of their personality. Extroverts use passion as a leadership tool.

Also on Thursday was Kristi Emmons Jones on Emotional Intelligence; unfortunately, we all ended up going into Lori G's session.





Leslie Brothers is the **Director of the Ulrich Museum of Art** where she has launched a new vision for the institution "the future now at the Ulrich." Programing includes a series of exhibitions entitled *Solving for X*, visualizations of campus research and "FUN" pecha kucha style presentations of scholarship across campus. Her focus is on connecting the Ulrich more directly to academic programs and research across campus in ways that invite and include community.

She was formerly the Director for 17 years of the McDonough Museum of Art, Youngstown State University's Center for Contemporary Art in Youngstown, Ohio. Leslie also served as an Adjunct Professor in the Department of Art teaching courses in contemporary art, theory, and in the potential for artists to affect change in society. She received her master's degree in Art History and Contemporary Criticism from Virginia Commonwealth University graduating with honors. She has a Bachelor of Arts Degree from the University of Wisconsin, Milwaukee where she majored in Art History and French. In addition, she received an honors degree in Women's Studies. Leslie is a museum professional who has worked in large municipal museums such as the Brooklyn Museum, the Virginia Museum of Fine Arts and the Milwaukee Art Museum, as well as University Museums and Galleries.

For Leslie, collaboration is part of the creative process. Her area of expertise is Contemporary Art and Culture and her research is based in rethinking the University Art Museum as a research center for understanding consciousness and human experience through the arts. Over the past 30 years, she has published exhibition catalogues, articles and reviews; she has organized over 60 exhibitions and created community-based programs that address the value of diversity, inclusion, equity and social justice, essential to maintaining relevance in the arts.

In 2014, she participated in TEDxYoungstown. Her talk can be found on YouTube, "Mattering is Key to Innovation in the University Art Museum." In 2017, she co-authored an NEA Our Town Grant funded at \$200,000 to commission 5 placemaking projects for the city of Youngstown.

She will speak on opportunities for things to happen at the museum that haven't really happened before and will demonstrate how a museum could matter at a university that has established innovation as their mode of operation. There are some exciting changes coming to the Ulrich Museum! Join us as we hear more about her vision for the future and accomplishments in the past year as the new Director.


